Collection of Personal Information

We collect personal information only when necessary to:

- Provide services and facilities at Newgreens Chatswood
- Respond to enquiries
- Improve customer experience
- Fulfil legal, regulatory, and operational requirements

Examples include membership applications, booking forms, event registrations, and feedback or incident reports. We may also collect information from third parties such as staff referrals or partner organisations to identify individuals who may benefit from Newgreens Chatswood offerings.

Website Usage & Cookies

When browsing our website, we do not collect personally identifiable information unless you voluntarily submit it. We use cookies to understand site usage patterns and improve functionality. These cookies do not identify you unless you provide personal information directly.

Sensitive Information

We do not collect sensitive information as defined under the Privacy Act—such as health, religion, ethnicity, or sexual orientation—unless legally required or with explicit consent.

Use & Disclosure of Personal Information

We use personal information for the purpose it was collected, typically to:

Deliver services



- Manage memberships
- Respond to enquiries

We may use or share your information to enhance service delivery, such as updating contact details across systems or coordinating with service providers. We may engage third-party providers who require access to personal information, including:

- IT support
- Payment processors
- Regulatory bodies

These partners are contractually bound to uphold strict privacy standards and use your data only for the agreed purpose.

Access & Correction

You may request access to your personal information or ask for corrections if you believe it is inaccurate or outdated. To do so, contact us via email at info@newgreenschatswood.com.au and provide sufficient identification and details of your request.

We reserve the right to refuse access or correction if legally justified but will provide reasons and allow you to submit a statement of dispute.

Data Security

We implement robust security measures to protect personal information from misuse, interference, loss, and unauthorised access. Access is restricted to staff and contractors who require it for operational duties.
